ORDER

The Jaipur Discom has got so many consumers of various categories, out of which 560027 Nos. of consumers are lying permanently disconnected. The outstanding dues against regular and PDC consumers are 2065 crore and 761 crore respectively. The efforts are being made by the Field Officers to recover the said dues from the consumers in regular fashion. The recovery of dues from the regular and PDC consumers is of utmost importance to improve the financial health of the Discom and bring down the AT&C losses from 21.42% to 15.00%. The efforts so far made indicate that the AT&C losses are expected to be reduced to 17.0% by 31st March, 2020, if due efforts are being continued to be made by all officers.

However, in order to recover the dues from regular consumers, PDC consumers and consumers against whom VCRs were drawn but not concluded, following instructions are issued for immediate compliance :-

- i) The premises of PDC consumers are checked for mis-use of electricity or theft of electricity, convincing the PDC consumers to avail the amnesty scheme to deposit the dues.
- ii) The premises of the consumers whose VCRs were drawn, but the assessment has not been settled, be checked for illegal restoration of supply.

- iii) To check and disconnect regular consumers having dues more than Rs.5,000/- in urban area and Rs.1,000/- in rural area
- iv) The entire team of the officers of all wings i.e. Vigilance, ATVS, M&P, Internal Audit, Energy Audit and HT maintenance be deputed to work under the guidance and program finalized by Circle SE w.e.f. 16th February, 2020 till 31st March, 2020. Feeder wise list is to be provided to team and regular monitoring is to be done at circle level.
- v) The ZCEs shall ensure the smooth and effective compliance of the above instructions and if need be he is authorized to provide extra resources like security guards, man-power, inspection or transportation vehicle in addition to already deployed.
