Sub:- Regarding responsibility of officers for ensuring logical conclusion of vigilance checking reports and rectification of high risk points.

Time and again it is being emphasised that every checking report should be concluded logically. It is being observed that vigilance checking reports being prepared U/S-135 & 138 are not being concluded logically as per procedure of JPR-5/1045. It is worthwhile to mention here that unless the VCR will not be concluded logically, very purpose to curb the electricity theft, tamper incidence of electric network and misuse cannot be stopped and will not create any fear among the culprits who are indulged in such activities.

In view of the above, to expedite the regular monitoring of such VCRs, the XEN(O&M) is responsible for logical conclusion for all the VCRs made in their jurisdiction and similarly XEN(Vig.) are also responsible for the checking reports made by them. SE(Vig.) and SE(O&M) will jointly review fortnightly progress of vigilance checking reports for its logical conclusion. The ZCE will also monitor fortnightly progress of such VCRs under their zone and will initiate disciplinary action against the defaulting officers.

Further, XEN(O&M) are also responsible for monitoring and ensuring timely rectification of high risk points as already been directed through DO letters as per time line upto 31.7.2021. The ZCE

along with CE(Trg. QC & Safety) will also monitor fortnightly progress of electrification of high risk points. Looking to the gravity of both the issues I hope you will not compel the management to take any adverse step.
