Terms & Conditions:-

1. In case any employee does not join within 15 days from issuance of this order, the promotion order in respect of him shall be deemed to have been automatically cancelled. If any employee is not willing to avail the chance of promotion, his controlling officer shall obtain his / her request about foregoing the chance of promotion, in writing, by the aforesaid date and send to this office.
2. No pay fixation benefit as a result of this promotion will be admissible to such employees who are already getting pay in Pay Matrix level-10 or higher as a result of grant of SG/ ACP. The employees, who are drawing pay in higher pay scale as Selection Grade/ACP, will however, continue to draw pay in the higher scale.
3. If any of the above employees is not interested to avail promotion, the request in writing about foregoing the promotion shall be obtained by the controlling officer from him and forwarded to this office. On foregoing promotion, he will not be considered for promotion in next 2 DPC years, and benefit of Selection Grade shall be withdrawn as per Order No. F&R/F.16 (13)-I/D. 40 dated 25.07.1997.
4. A copy of joining report of concerned employees is sent to this office by Personnel Officer/controlling officer by 10.08.2022
5. In case any of the employee is under suspension or absconding or against him any DE/PE is pending or any penalty has been imposed against him during last 7 years, the promotion order, in respect of such employee, shall not be made operative and the controlling officer shall intimate the position to this office, immediately.
