**NOTIFICATION**

Jaipur, dated : June 05, 2013.

In exercise of the powers conferred by section 3 of the Rajasthan Electricity (Duty) Act, 1962 (Act No.12 of 1962) and in supersession of this Department's notification No.F.12 (118) FD / Tax / 2009-49 dated 05.08.2010, the State Government being of the opinion that it is expedient in the public interest so to do, hereby, with immediate effect, remits the electricity duty, for a period of seven years, payable on the energy consumed in manufacture, production or processing of goods by such eligible enterprises which have been established / shall be established as per the sanction granted by the State Level Empowered Committee or District Level Sanctioning Committee, as the case may be, constituted under the Policy for Promotion of Agro-Processing and Agri-Business, 2010 provided that sanction for such eligible enterprises has been issued prior to 31.03.2014 under the Policy for Promotion of Agro-Processing and Agri-Business, 2010.

राजस्थान विद्युत (शुल्क) अधिनियम, 1962 (1962 का अधिनियम सं. 12) की धारा 3 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए और इस विभाग की अधिसूचना सं. एफ. 12(118)एफ.डी./टैक्स/2009-49, दिनांक 05.08.2010, को अतिष्ठित करते हुए राज्य सरकार, यह राय होने पर कि लोकहित में ऐसा किया जाना समीचीन है, ऐसे पात्र उद्यम, जो कृषि प्रसंस्करण एवं कृषि व्यवसाय प्रोत्साहन नीति, 2010 के अधीन गठित राज्य स्तरीय अधिकार प्राप्त समिति या, यथास्थिति, जिला स्तरीय स्वीकृति समिति द्वारा प्रदत्त मंजूरी के अनुसार स्थापित किये गये हैं/स्थापित किये जायेंगे, द्वारा माल के विनिर्माण, उत्पादन और प्रसंस्करण में उपभुक्त ऊर्जा पर संदेय विद्युत शुल्क से, सात वर्षों की कालावधि के लिए, इसके द्वारा तुरन्त प्रभाव से छूट प्रदान करती है, परन्तु यह कि ऐसे पात्र उद्यमों के लिए मंजूरी कृषि प्रसंस्करण एवं कृषि व्यवसाय प्रोत्साहन नीति, 2010 के अधीन 31.03.2014 के पूर्व जारी की जा चुकी है।
