The permission to prosecute further studies is given subject to the following terms & conditions:-

1. The office work will not suffer on this account.
2. No permission will be given to attend late or to leave office early.
3. He/She will not be allowed any leave for the purpose of such studies except leave required for the days of examination.
4. If at any time it is found that there is a tendency on the part of the official to be indifferent or slack in discharging of his/her duties, permission will be withdrawn without assigning any reasons.
5. Permission will also be withdrawn at any time, if the timing of classes is found to be determinate to the official duties of the official.
6. If at any time official is transferred from the present headquarter to elsewhere in the interest of the Nigam's work no consideration will be given on the ground of such permission.
7. That the Nigam's authorities competent to make transfer do not guarantee the posting of the same place where he/she is prosecuting higher studies and if the official required to be posted away from the station of prosecuting higher studies in the interest of the Nigam's work it will be done. Thus it is at own risk and it should not be presumed that he/she will be stationed all the time at the same station/place.
