

ORDER

Sub. : "Amnesty Scheme" for realisation of outstanding dues from running Agriculture, domestic in rural areas, domestic in Kachchi Basties of Urban areas and for disconnected consumers of all categories except Industrial categories.

With a view to recover the outstanding dues from the various category of disconnected consumers (disconnected up to or before 30.9.07) and running consumers (as listed below), it has been decided to allow following concessional package for various category of consumers up to 31.3.08. This concessional package shall be available if the consumer deposits the total outstanding dues in lump sum :-

(i)	<p><u>For running connections</u></p> <p><u>Agriculture category-domestic in rural areas and domestic in Kachi Basties of urban areas</u></p>	<p>Component of DPs in the outstanding amount as on 30.9.2007 shall be waived off and only principal amount of outstanding as on 30.9.2007 shall be recovered. The principal amount accumulated from 1.10.07 to date of payment, shall also be recovered along with DPS on full principal amount (including Principal amount as on 30.9.07 after waiver of DPS upto 30.9.07).</p>

(H)	<p><u>For disconnected connections</u></p> <p>For all category of consumers except industrial categories.</p>	<p>Component of DPS and interest in the outstanding amount as on 30.9.07 shall be waived off, The principal amount of outstanding dues as on 30-9-07 shall be recovered alongwith interest @ 6% per annum from 1-10-07 to the date of payment.</p>

Terms & Conditions

1. The Scheme shall remain in force up to 31.3.08.
2. The scheme shall be applicable irrespective of whether the disconnected consumer wants reconnection or not.
3. This scheme will not be applicable for the amount of assessment made against theft of electricity &/or malpractice.
4. This scheme shall not be applicable for consumer(s) who have availed benefits under Amnesty Schemes announced by Jaipur Discom during the year 2004-05, 2005-06 & 2006-07.
5. For availing the concession package, the consumer shall be required to apply to the concerned Asstt. Engineer in the format enclosed at Annexure-'A'.
6. Concerned Asstt. Engineer is empowered for allowing the rebate in Delayed Payment Surcharge (DPS)/Interest as per the scheme.
7. To avail these concessions the consumer shall voluntarily undertake to withdraw all the Court cases, if any, pending in any Court of Law/ Consumer Forum/MRTP Commission/any other competent agency etc., related to the outstanding dues.

8. The disconnected agriculture connections shall be reconnected in accordance with the prevailing Agriculture Policy. The disconnected connections of other categories shall be reconnected as per prevailing Nigam's rules.
9. The outstanding dues should be worked out without taking into consideration the adjustment of existing security deposit. However, adjustment of security deposit may be made for disconnected consumers in the dues so worked out as on date of disconnection and from such consumers revised security deposit shall be obtained as per provisions of TCS-04 before reconnection..
10. The disconnected consumers will be allowed reconnection after depositing the full amount calculated as above. However, provisions of time period for reconnection as per Clause-47 of TCS-04, (latest amended) shall not be applicable on the cases under this scheme. If, for reconnection, any additional line is required to be laid, the cost of the same shall be borne by the consumer otherwise reconnection shall be allowed on payment of only prescribed "Reconnection charges".
11. If the consumer fails to deposit the amount upto 31-3-08 the concession package, shall not be available.
