ORDER

Sub.:- "Amnesty Scheme" for all categories of consumers – realization of outstanding dues thereof.


With a view to recover the outstanding dues from the consumers disconnected up to or before 31.3.09 and running consumers, it has been decided to allow following concessional package for various categories of consumers for a period from 15-04-2010 to 16-06-2010, if the consumer deposits the total outstanding dues the lump sum on or before 16.06.2010.

	Brief Description	Concessions allowed
1.	All categories consumers (Running as well as disconnected). Clearance of outstanding dues as on 31.3.2009.	<p>(i) <u>For running connections</u> Component of LPS/DPS in the outstanding amount as on 31.3.2009 shall be waived off and only principal amount of outstanding as on 31.3.2009 shall be recovered. The principal amount accumulated shall also be recovered along with LPS/DPS on full principal amount for the period 1.4.2009 to date of payment.</p> <p>(ii) <u>For disconnected connections</u> Component of LPS/DPS/interest on the outstanding amount as on 31.3.2009 shall be waived off. The principal amount of outstanding dues as on 31.3.09 shall be recovered along with 6% per annum interest from 1.4.2009 to date of payment.</p>

Terms & Conditions :

- I. The Scheme shall be made available for a period 15.04.10 to 16.06.10 (i.e. date of realization).
- II. One time payment is to be taken and no installment is allowed
- III. Concerned Asstt. Engineer is empowered for allowing rebate in DPS/interest for all categories of consumers and for Large Industrial category, Dy. Chief Engineer (Comml.) is empowered to allow rebate in LPS/interest as per the scheme.
- IV. The scheme shall be applicable irrespective of whether the disconnected consumer wants reconnection or not.
- V. To avail these concessions the consumer shall voluntarily undertake to withdraw all the Court cases, if any, pending in any Court of Law/Consumer Forum/MRTP Commission/any other competent agency etc. related to the outstanding dues.
- VI. If the consumer fails to deposit the amount as per agreed time schedule under this concession package, this facility shall be withdrawn.
- VII. This concession package will not be applicable for the amount of assessment made against theft of electricity &/or malpractice.
- VIII. This scheme shall not be available for consumers who have availed benefits under the Amnesty Schemes announced during the years 2007-08 or 2008-09.
- IX. For availing the concession package, the consumer shall be required to apply to the concerned Asstt. Engineer for all categories of consumers except large industrial category and to the Dy. Chief Engineer (Comml.) for the Large Industrial Category of consumers, in the format enclosed at Annexure - A.
- X. The outstanding dues should be worked out without taking into consideration the adjustment of existing security deposit in case of regular consumers. However, adjustment of security deposit may be made for disconnected consumers on the dues so worked out as on date of disconnection and from such consumers, revised security deposit shall be obtained as per rules before reconnection, if any.
