



CIRCULAR

Sub.:- Levy of minimum billing amount in case of Permanently Disconnected connection under Seasonal Industrial category.

The matter of levy of minimum billing amount on the seasonal industrial consumers who are disconnected permanently during the seasonal period was examined by RERC. After detailed examination, the Hon'ble Commission has clarified that seasonal industries are also to be treated at par with non-seasonal i.e. normal industries particularly in respect of levy of minimum billing amount during the period of disconnection, agreemental period etc.

Accordingly it is hereby clarified that the seasonal industries should also not be charged for minimum billing during the disconnected period after disconnection at par with normal industrial consumers. The other provisions such as notice period, agreemental period etc. as prevailing for non-seasonal industries shall also be applicable for the seasonal industrial consumers as well.
