## NOTIFICATION

In exercise of the powers conferred by sub-section (3) of Section 3 of the Rajsthan Electricity (Duty) Act, 1962 (Rajasthan Act No. 12 of 1962), the State Government being of the opinion that it is expedient in the public interest, so to do, hereby remits Electricity Duty payable by the new projects, having a total new investment as per column No. 2 of the table given below, on self generated energy in respect of their new investment in the captive power plant; as approved by the prescribed authority under the provisions of the Rajasthan Investment Promotion Scheme 2003, for 7 years, to the extent as mentioned in column No. 3 of the table :
