CIRCULAR

Sub: Unguarded electric lines passing over educational institutions.

During discussions in the Senior Officers Conference held on 25-9-06, it was pointed out that some of the electric lines passing over schools are without guarding due to which these can be accidents. In this context, it is advised that after identification of such unguarded locations it must be ensured that no electric line passing over the educational institution(s) building remains unguarded. After completion of the job, the concerned sub-divisional officers shall furnish a certificate that there is not a single case where the overhead line is passing over education institution and is still unguarded. Such reports shall be compiled at circle level and circle SE is expected to apprise the position to the Hon'ble CMD in Circle level meetings.
