ORDER

Sub: Switching over to monthly billing system from bi-monthly billing system in case of consumers having sanctioned connected load above 25 HP (18.75KW) under Domestic, Non-Domestic and Mixed Load Categories.

With the introduction of new Tariff with effect from April 1, 2001, "Power Factor Surcharge clause" has also been made applicable for consumers having sanctioned connected load above 25 HP (18.75 KW) under Domestic/Non Domestic and Mixed load categories. For the purpose of implementation of this provision of tariff, monthly readings of KWh & KVAh meters installed at consumers' premises are required to be obtained.

Since presently the above mentioned categories of consumers are being billed on bi-monthly basis hence accordingly the current reading programme has been arranged in such a manner that readings of KWH & KVAH meters of these categories are taken once in a period of 2 months. For the purpose of implementation of the provisions of tariff regarding power factor, readings of meters are required every month. It has been, therefore, decided that in case of consumers having sanctioned connected load above 25 HP (18.75 KW) under Domestic, Non-Domestic & Mixed load categories, readings of meters be obtained/ taken every month and forwarded to the billing agencies for billing such consumers on monthly basis instead of the prevailing practice of billing on bi-monthly basis.

The above mentioned billing procedure shall be applicable w.e.f. the billing month of January'2002 and it should be ensured by the field officer that above instructions are implemented timely.
