
ORDER

Sub : Levy of overhead charges in preparing estimates
for MPs/MLAs/BADP aided development works.

In pursuance to the decision taken by the Coordination Committee in its 43rd meeting held on 11-7-2002, following instructions are issued for implementation:-

The MPs/MLAs/BADPs aided development works shall be carried-out on "Cost Sharing Basis" i.e. the cost of material shall be borne by the MPs/MLAs/BADP and labour & other costs shall be borne by the Jaipur Discom. However, the above decision would be applicable only for RE and 33/11 KV augmentation.
