Medical Concession Scheme. 1992.


In continuation to earlier order No.RVVPN/AO/GAD/F&R/F. /D/756 dated 18.7.2002 the matter has been reconsidered by the Chairman and Managing Director and Director (F&CA) and decided to revise the fee (renewal charges of Identity Card form PMCF-2) w.e.f.1.4.2002 as under: -

1.	Pensioners who were in receipt Of pay in scale No.1 to 6 at the time of retirement.	150.00	1500.00
2.	Pensioners who were in receipt of pay in scale No.7 and onwards.	300.00	3000.00

The pensioners who have deposited fee for whole life Identity Card (PMCF-2) at old rates by 31st March, 2002 shall not be required to deposit additional amount on this account.

It is enjoined upon all the Circle Accounts Officers to ensure that difference of membership fee (renewal fee of Identity Card PMCF-2) is recovered/refunded from/to the pensioners from whom the same, at old rates, have been received from 1.4.2002 and onwards. All the Circle accounts Officers and other pension payment authorities shall provide information in this connection to the CAO (P&F) in the proforma enclosed at Annexure-A.

The revised rates of membership fee from 1.4.2002 shall also be applicable in respect of the pensioners of the companies getting pension in other States and are entitled to fixed medical allowance @ Rs.100/- P.M. The difference amount of membership shall not be recovered from the pensioners who have remitted membership fee at old rates by 31.3.2002. This order shall also be applicable on the pensioners having CPF.




