ORDER

Sub :- Amendment in purchase manual-1999

The Board of Directors in its 40th meeting held on 2nd June, 2003 has decided to make the following amendment in clause 1.40.2 - "Maintenance and guarantee" of the General Conditions of Contract (GCC)-Schedule-II to the Purchase manual, 1999 in respect of poles & conductors :-

(a) For Transformers :

30 months from the date of despatch of transformers.

(b) For all other materials / equipments :

12 months from the date of commissioning or 18 months from the date of receipt of the last consignment at site/stores, whichever is earlier.

The above amendments be made applicable with retrospective effect i.e. the contract/purchase orders of poles and conductors already having stipulated performance/guarantee period as '6 months after commissioning' be deemed to have the same as '12 months from the date of commissioning or 18 months from the date of receipt of the last consignment at site/stores, whichever is earlier' so that these pending contracts could be finalized and performance bank guarantee/financial holds thereof could be released accordingly.

The Board of Directors has further decided to authorise the Corporate Level Purchase Committee to enhance the guarantee/performance period in respect of any of the materials/items, in future, if required.
