CIRCULAR

Subj:- Interest on House Building/
Conveyance Advance.

Vide erstwhile RSEB order No. RSEB/F&R/F. 21(2)II/ Q. 1 dt. 12.1.1994 the " words interest @ 15% (rate of interest) wherever appearing in sub-regulation 10 of Regulation 3 of House Building Advance and Sub-regulation (vii) of Regulation 3 of RSEB Regulations for the grant of advance for purchase of conveyance may be substituted by words " penal rate @ 2-1/2% of above the simple rate of advance w.e.f. 1.4.93. References from the Unit officers as well as from the employees are powering in to charge the rate of interest (in case of default) @ 2.5% above the simple rate of interest applicable at the time of sanctioning the loan irrespective of quantum of recovery, whether 50% of basic pay or otherwise.

The matter has been examined/ re-considered and CMP RVPN in consultation with Director(F&CA) has been pleased to order that in case of default on the part of employees, interest on House Building Advance/ Conveyance Advance is to be charged @ 2.5% over and above the simple rate of interest mentioned in the sanction order in all cases w.e.f. 1.4.93. In case recovery has been made at higher rates w.e.f. 1.4.1993 the amount may be refunded to the employees concerned.


