**ORDER**

**Sub: Amendment in the RSEB Officers Service (Recruitment, Promotion & Seniority) Regulations, 1974.**

The Chairman & Managing Director, Jaipur Discom, has been pleased to make following amendments in the RSEB – Officers Service (Recruitment, Promotion & Seniority) Regulations, 1974 namely :-

In the said regulations-

The existing entries at item No. 2 of Col. 4 against item (b) of Col. 3 and the existing entries of Col. 4 against item (c) of Col. 3 of Sl. No. 19 of Schedule appended to these rules shall be substituted by the following:-

(b) 35% by promotion on the basis of merit-cum-seniority

2) 30% by promotion out of the Acetts. possessing the qualification as given below with atleast 7 years service as Accountant in Nigam-

C.A. (Member of the Institute of Chartered Accountants in India).

OR

Having the qualification of Cost & Works Accountant awarded by the Indian Institute of Cost & Works Accountants, Calcutta.

OR

M.B.A. (Finance)

OR

Passed Intermediate Exam. of the Indian Institute of Cost & Works Accountants, Calcutta/C.A. (Inter) and possessing 5 years post qualification experience of working as Accountant in Nigam.

OR

A graduate holding Diploma in Cost & Works Accounts from a University established by law in India and possessing 5 years post qualification experience of working as Accountant in Nigam.

(c) 15% by limited direct recruitment.

From amongst the departmental candidates who possess the qualification of:

i) ICWA (Final)

OR

ii) C.A.

OR

iii) M.B.A. (Finance)

OR

iv) CA (Inter) or ICWA ((Inter) or Diploma in Cost & Works Accounts of any recognized University of India with 7 years experience of working as Junior Accountant or 5 years experience as Accountant in the Nigam, such experience being reckoned from the date of passing examination.


