Sub: Extension of time limit of reduced rate of Sales tax
To electricity companies.

S.O. - IN exercise of the powers conferred by Section 15 of the Rajasthan Sales tax Act, 1994 (Rajasthan Act No.22 of 1995), the State Government being of the opinion that it is expedient in the public interest so to do, hereby makes the following amendment in this Department, Notification No.F.4(24)FD/Tax Div/90-140 dated 13.3.2002, namely:-

AMENDMENT

In the said Notification, for the existing expression, "Upto 31.3.2004 or the date on which the Rajasthan Value Added Tax Act, 2003 comes into force, whichever is earlier", the expression "Upto 31.03.2005 or the date on which the Rajasthan Value Added Tax Act, 2003 comes into force, whichever is earlier" shall be substituted.
