## ORDER

### Sub:- Grant of Assured Career Progression under Rajasthan Civil Services ( Revised Pay) Rules, 2008.

In exercise of powers conferred vide order No. JPD/CAO(IA)/AO/Rules/ F.90/ D. 3203 dated 20.01.2014 (JPD/Rules-939), the Managing Director has been pleased to adopt the State Government's Memorandums No. F.44(88)FD/Rules/2008-I dated 01.06.2017 and No. 14(88)FD/Rules/2008-II dated 01.06.2017.

Accordingly, the existing item (iii) of Sub para (7) of para 2 of Nigam's Order No. JPD/CAO(ATR)/AO/Rules/F.40/D.1060 dated 26.05.2010 (JPD/Rules-646) and item No. (iii) of sub para (8) of para 2 of Nigams order No. JPD/CAO(ATR)/AO/Rules/F.40/D.1059 dated 26.05.2010 (JPD/Rules-647) shall be substituted by the following, namely: -

*"The appointing authority shall also obtain an affidavit from the employee with reference to having only two children on or after 01.06.2002 prior to granting ACP. An employee who has more than two children on or after 1.06.2002 shall not be granted next ACP for 3 years from the date on which his ACP is become due and it would have consequential effect on the subsequent financial upgradation which would also get deferred to the extent of delay in grant of previous financial upgradation. The employee having more than two children shall not be deemed to have been disqualified, so long as the number of children he/she has on 01.06.2002 does not increase."*


