OFFICE-ORDER


Vide office order No. JPD/CAO(IA)/AAO (Estt. Cont.)/F./D. 149 dated 17.04.2013 the 'hiring of Vehicle with Manpower' under item No. 23.18 of CLRC @ 65,000/- per month was allowed upto 30th July, 2013 which was subsequently extended upto 30th October, 2013 vide order no. 1330 dated 05.08.2013 and further extended upto 31st March, 2014 vide order No. 2249 dated 29.10.2013.

It has been observed that the expenditure so made on the above account has not translated into the desired results / achievements, for which the scheme was put in place. Therefore it has been considered expedient that all concerned must ensure not to continue such 'hiring of Vehicle with Manpower' under item No. 23.18 under Chapter 23(A) of the CLRC @ 65,000/- per month beyond 31st March, 2014 in any case. However if there is any need based requirement, complete case of such requirement with justification as per Nigam's order No. JPD/SE(TW)/XEN(TW)/CLRC-2012/OO- 45 & 46 /D. 1670 & 1671 both dated 08.10.2012 be sent through the concerned Chief Engineer to the CAO (IA), JPD, Jaipur for seeking prior approval of the undersigned. In no case such 'hiring of vehicle with manpower', in question, be engaged without specific prior approval, in writing, from the corporate office.
