Sub: Contribution of EDLI.

It has been observed by this office that some Circle Accounts Officers are contributing EDLI contribution @ 0.05% of Basic plus D.A whereas some AO's are contributing EDLI contribution @ 0.05% of Basic plus D.A subject to maximum wage ceiling of Rs.15000/-.

As per employees EDLI scheme 1976 amount to be calculated on the basis of basic wages, dearness allowance (including the cash value of any food concession) and retaining allowance, if any, actually drawn during the whole month. Provided that where the monthly pay of employee exceeds fifteen thousand rupees the contribution payable in respect of him by the employer shall be limited to the amounts payable on a monthly pay of fifteen thousand.

Therefore, making uniformity in EDLI contribution, all circle AO's are hereby directed to deduct EDLI contribution as per EDLI scheme 1976 i.e @0.05.% of Basic plus D.A subject to maximum wage ceiling of Rs. 15000/-.
