CIRCULAR

Instructions were issued vide order No. JPD/CAO/Rev./F.325/D. 332(PS) dated 17.01.03 for hiring services of ex-servicemen through Jaipur Ex-Servicemen Welfare Co-operative Society Ltd., Jaipur for various jobs on terms & conditions, mentioned in said order as well as orders, issued by the State Government from time to time. Subsequently, vide order No. JPD/PERS/D-III/F.24(D)1/D. 100 dated 28.01.04, the Circle SEs were also authorised to hire services of ex-servicemen from District Soldier Board of concerned area, if the Jaipur Ex-Servicemen Welfare Co-operative Society Ltd., Jaipur is not in position to provide services of ex-service personnel, as per authorisation done by order dated 17.01.03.

It has been intimated by some Circle officers that neither Jaipur Ex-Servicemen Welfare Co-operative Society Ltd., Jaipur nor District Soldier Board of concerned area are able to provide services of ex-servicemen, but they could not hire services of ex-servicemen from other Ex-Servicemen Welfare Co-operative Societies, as per authorisation done vide aforesaid orders. The matter has been considered by the CMD and it has been decided that the Circle SEs and other authorised officers may hire services of ex-servicemen from any authorised Ex-Servicemen Welfare Co-operative Society, which has valid registration and licence and fulfils other terms & conditions, as laid down by the State Government for providing services of ex-servicemen, after proper screening at their level. However, other terms & conditions for hiring services of ex-service personnel shall remain the same, as mentioned in order dated 17.01.03 and orders issued subsequently on the subject.
