**ORDER**

Sub:- Scheme for grant of Medical Concession to the Pensioners of Power Sector Companies.

The Chairman and Managing Director, RVPN, in exercise of powers conferred vide order No. RVPN/CAO/P&F/PMCF/D.3957 dated 6.8.2001, is pleased to adopt the GoR order No. F.1 (13) FD (Rules)/2008 dated 19.06.09, vide which the rate of subscription to the fund for the Government Servants, who were drawing pay in the Rajasthan Civil Services (Revised Pay Scales) Rules, 1998, and under pay scale rules in force prior to 01.09.2006 has been prescribed/enhanced. Accordingly, the existing para 4 (a) of the Rajasthan State Electricity Board Pensioners Medical Concessions Scheme, 1991, shall be renumbered as 4 (a) (i) and a new para 4 (a) (ii) shall be inserted as follows, namely:-

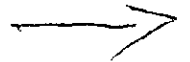


