In consideration of the proposal furnished vide letter under reference, I am directed to convey the administrative approval of MD as per item 2(b) of D.O.P, for the following 33 KV works:-

- (i) Erection of 7.5 KM 33 KV S/C O/H line on ACSR Dog Conductor T-off from 33 KV Talawada feeder which is emanating from 132 KV GSS Khandar at a distance of 2 KM from 132 KV GSS Khandar to existing 33 KV B. Kalan feeder at a distance of 11.3 KM from 33/11 KV S/S Baler


Note:1) The 33/11 KV S/Ss B. Kalan and Baler will remain on 33 KV B. Kalan feeder emanating from 132 KV GSS Khandar whereas, 33/11 KV S/Ss Talawada, Kabeerpura and Singor Kalan will remain on 33 KV Talawada feeder from 132 KV GSS Khandar.

Note:2) The above works are included in Annual Phase Programme 2018-19, under DDUGJY scheme.
