Sub:- Payment of interest on security deposited by other than large industrial consumers.

As per Clause No.18 of the Terms & Conditions for supply of Electricity-2004, interest on consumers security deposit (security for consumption & security for meter) for the year 2010-11 is to be allowed to all categories of consumers through credit adjustment in the electricity bills for billing month of July,11 & Aug.11 @ 6% per annum. The rates of TDS would be as under. Credit of interest in bills would be carried out by the computer agencies for which no advice from sub-divisions shall be required to be sent.

(a) Where Form G or H provided or where valid exemption certificate issued by the Income Tax Deptt. Have provided by the consumer	Nil
(b) Domestic company (Registered in India)	10.00%
(c) Partnership Firm	10.00%

A rubber seal is to be affixed in Hindi on each energy bill to be issued to consumers intimating them to approach unit officer in case of variation in the amount of security, if any alongwith original cash receipts and photo copies thereof. In case of spot billing please arrange to provide a rubber seal to each meter reader to ensure that the seal is affixed on the bill before delivery to the consumer.

The calculation of interest on security is subject to the terms and condition mentioned in the following orders:

- (1) JPD/CAO/Rev./F.388/D.3373 dated 28.1.06 (JPD-6/188) for ceiling of maximum amount which is now further extended to the PSL and Mixed Load category also where the billing is done through spot billing equivalent to SIP category.
- (2) No.3599 dt.18.2.06 (JPD-6/190)
- (3) No.3731 dt.3.3.06(JPD-6/193)

Since interest on security deposited by the consumers under PSL, MIP & Mixed Load categories where billing is not through spot billing will be allowed by the computer agencies without any ceiling, figures of interest allowed will be checked and verified in each case by the unit officers prior to issue of energy bills.

Certain consumers may have deposited the higher amount than the ceiling prescribed or where interest could not be allowed by the computer agency due to non availability of security details with them, the unit officers will allow interest in such cases after due verification from cash receipts provided by the consumers & available records and simultaneously completing the records thereof in a register to be maintained allotting pages therein binder wise for further verification by audit wing / inspecting officers. Interest so allowed to consumers will further be sent through Input Advice CB-12 to computer agencies under transaction code 54 for incorporating the amount of realization through adjustment in consumer account, accordingly.

**Sub:- Payment of interest on security deposited by other than large industrial consumers.**

The coordination committee in its meeting held on 24.1.06 have decided to allow interest on the amount of security deposited by the other than large industrial consumers for the period from 13.8.04 to 31.3.05 @ 6% per annum, on the basis of figures available with the computer agencies, with immediate effect. Since figures available with the computer agencies may not be very exact in stray cases, category wise ceiling on the amount of security deposited for the purpose (ceiling amount or amount available with the computer agencies whichever is less) of allowing interest by the computer agencies, were also prescribed as under:-

S.No.	Category of consumers	Maximum amount of security on which interest may be allowed.
1.	Domestic	Rs.1,000.00
2.	Non-domestic	Rs.2,000.00
3.	Agriculture	Rs.1,700.00
4.	SIP	Rs.5,000.00
5.	PSL, MIP & ML	As per figures available with computer agencies but individual case to be examined and verified cent percent at unit office level.

Interest so allowed will be treated as realization through adjustment under transaction code 54 and will be shown in energy bills and MIS 3.2, accordingly. The computer agencies will provide details of security available and interest allowed consumer wise, to each unit officer weekly and will further provide totals of such figures unit wise to each Circle Accounts Officer and Corporate Office, monthly.

It is, therefore, advised to affix a rubber seal in Hindi on each energy bill to be issued to consumers intimating them about the amount of security available, interest allowed and to approach unit officer in case of variation in the amount of security, if any with original cash receipts and photo copies thereof. Specimen of seal to be affixed by the unit officer is given hereunder :-

Since interest on security deposited by the consumers under PSL, MIP & Mixed Load categories will be allowed by the computer agencies without any ceiling, figures of interest allowed will be checked and verified in each case by the unit officer prior to issue of energy bills.

Certain consumers may have deposited the higher amount than the ceiling prescribed aforesaid or where interest could not be allowed by the computer agencies due to non availability of security details with them, the unit officers will allow interest in such cases after due verification from cash receipts provided by the consumers & available records and simultaneously completing the records thereof in a register to be maintained allotting pages therein binder wise for further verification by audit wing / inspecting officers. Interest so allowed to consumers will further be sent through input advice CB-12 to computer agencies under transaction code 54 for incorporating the amount of realisation through adjustment in consumer account, accordingly.

**ORDER**

As per clause No,18 of the Terms & Conditions for Supply of Electricity 2004, interest on consumer security deposit (CSD) is to be allowed to all categories of consumers w.e.f. 13.8.2004 at bank rate as existing on 1<sup>st</sup> April of every year. Such bank rate shall be intimated by the corporate office from time to time. As the interest on consumer security deposit could not be allowed to other than large industrial consumers in the prescribed period i.e. July 05 to Sept.05. Now interest @ 6% is being allowed in the billing month of Feb. 06, March, 06 & April, 06 as per instructions issued vide this office letter No.JPD/CAO/Rev./F.388/D.3373 dt.28.1.06. Further accounting and taxation instructions are hereby conveyed as under only for the interest to be allowed for the year 2004-05 wherein Rs.5000/- or above and instructions for ensuing year will be issued separately

- (i) Soon after receipt of energy bills from the computer agency, ARO of the unit will ensure that no energy bill is delivered to consumers where amount of interest allowed by the computer agencies are of **Rs.5000/- or above**.
- (ii) After segregation of such energy bills (item (i) above), authenticity of the interest allowed will first be ascertained by the ARO with the amount of security deposited by the consumer and will further contact to consumers immediately to get their PAN no., Form G or H (as the case may be) or valid exemption certificate issued by the competent authority of the Income Tax Deptt.
- (iii) Since, no income tax is being deducted by the computer agencies on the amount of interest allowed, at present; TDS will be deducted through CC&AR by the Unit Officer concerned immediately after taking the exercise as at (ii) above in such cases at following rates, from the energy bill and will reduce the amount of interest shown in the bill to the extent of TDS amount, manually.

- (iv) List of consumer against whom TDS have been deducted will further be sent to the Circle Accounts Officer by the Unit Officer immediately prior to close of the billing month in proforma enclosed as **Annexure-A** alongwith Jr.Vr. as under, so as to enable him for payment of the amount of TDS to the Income Tax Deptt. by due date .

23.101 Sundry debtors for sale of power (Dr.)

46.929 Income Tax deducted at source on payment of interest on CSD (Cr.)

Record of such cases in a register will be maintained also at sub-divisional level showing consumer wise details in the proforma at Annexure-A.

(v) There will no need to further send the Jr.Vrs. with the MIS for the above transactions under code 56 for which Jr.Vrs. already sent as per instructions at item (iv) above.

(vi) Debit against Sundry Debtors for sale of power will further be sent to computer agencies in next billing cycle through input advice CB-12 under transaction code 56 being prescribed for Income tax deducted at source, for the amount deducted as per item (iii) & (iv) above.

(vii) Where interest on security allowed, on verification, is found to be less or excess (excluding cases of Rs.5000/- or above where action prescribed hereinabove is to be performed necessarily), necessary debit or credit advice be sent through input advice CB-12 to computer agencies under transaction code 54

(viii) After receipt of MIS from computer agencies, following Jr.Vr. will further be prepared by the Unit Officer and send to the Circle Accounts Officer alongwith the MIS concerned for the amount under transaction code 54.

(ix) The prescribed returns of TDS will be furnished on scheduled date by the Circle Accounts Officer to the concerned Income Tax Officer.

The order will come into force with immediate effect.




2. Where date of connection is not available, than security amount may be considered as below:-

Category of consumers	Security amount
(i) Domestic & Non domestic Upto 10 KW connected load	Rs.10/- per 0.5 KW connected load or part thereof
(ii) Domestic & Non domestic Above 10 KW connected load	Rs.10/- per 0.5 KW connected load or part thereof
(iii) Motive power (Ag.SIP/MIP)	Rs.15/- per BHP connected load or part thereof

3. No security amount is to be considered as above for the consumers, who are exempted from deposit of security i.e. Central/State Govt. Departments, Kutir Jyoti connections etc.
4. The amount of security so worked out as per item No.1 & 2 above, will be shown in the ledger / information to be provided by suffixing of "P" after the amount, in respect of each consumer.
5. Consumer wise list of such cases will also be provided by you to each Unit Officer with each billing cycle.
6. Interest already allotted to the consumers w.e.f.13.8.04 may further be revised w.e.f.10.6.04 & remaining interest will further be allowed in subsequent billing cycles.

The Unit officer will follow the instruction issued vide letter No.JPD/CAO/Rev./F.388/ D.3373 dt.28.1.06 & order No.JPD-6/190 dt.18.2.06 in regard to issue of bills, completion of security deposit record and deduction of TDS at source etc. and further send the advice in MF-2E for correct amount of security deposit found available in his office or with consumers after due verification from the record.
