### ORDER

#### Sub:- Recovery under EUDR & LR Act.

In the Sr. Officer's Conference held at Jaipur on 8<sup>th</sup> October, 2011, it was observed that effective action is not being taken to recover the old outstanding dues against PDC consumers under EUDR & LR Act. The quantum of outstanding is being increased year to year. The CMD, Jaipur Discom has expressed his serious concern and advised to all Field Officers that looking to financial crunch in the Discoms, it is essential that whatever amount is remained unpaid against energy bills should be collected by making all efforts under EUDR & LR Act. The XENs (O&M) are vested the powers under LR ACT.

Further detailed instructions in this regard were already issued vide order No.JPD/CAO(ATR)/Rev./D.827 dated 20.04.2011 and progress report in the prescribed proforma by 10<sup>th</sup> of the following month was desired from each Circle SE but it is a matter of regret that response has not been received.

It is hereby, enjoined upon all concerned that steps for recovery of dues under said Act may be started immediately. For facilitating in issue of notices having outstanding dues more than 1.00 lac in respect of PDC consumers, following offices are hereby directed to ensure that in the first instance notices to these consumers are issued within a period of 30 days positively and detailed list showing their Name,

amount, Notice No. and date may be informed to the CAO(ATR), Jaipur Discom for further monitoring. Simultaneously notices to other than above category be arranged by the Sub-division as well as Division Offices.
