Sub:- Recovery of old arrears from PDC consumers under EUDR Act and LR Act and honorarium thereof.

The quantum of increasing amount outstanding against PDC consumers has drawn attention of management. The outcome of the implementation of provision of EUDR/LR Act is very slow and needs overall review. In order to accelerate present pace of recovery of old arrears from PDC consumers, under EUDR & LR Act, the issue of honorarium to Officers/ Officials of Vigilance wing was discussed in the 210th meeting of Board of Directors held on 28.1.13 and it was decided to utilize the services of APTPS personnel for EUDR & LR Act proceedings and they will be eligible for honorarium as under :-

1. Recovery of PDC cases under EUDR Act for delivery and acknowledgement of notice, preparation of detail of property to be attached	3% (1% + 2%) honorarium of realized amount, subject to maximum of Rs.5,000/- in each case.
2. Recovery of PDC cases under LR Act for delivery and acknowledgement of writ of demand, processing "Kurki" of the property, for making publicity by playing drums or using loudspeaker at the place of property and etc.	3% (1% + 2%) honorarium of realized amount, subject to maximum of Rs.5,000/- in each case.

The 1% honorarium of the recovered amount under EUDR Act and LR Act will be released immediately and remaining 2% honorarium will be released only after recovery of at least 10% of the dues against PDC consumers as on 31.3.12 circle as a whole. The honorarium will be allowable only if recovery is made during the period w.e.f. 1.2.2013 to 31.3.2014. The total amount of honorarium will be 3% of recovered amount subject to maximum of Rs.5000/- in each case. In case the minimum target of Circle is not achieved, but recovery under EUDR/LR Act is made then only 1% honorarium will be allowed. The bifurcation of honorarium will be as under :-

- (i) 10% of admissible honorarium amount to Addl.S.P. and Ministerial staff of his office (5% of admissible amount to Addl.S.P. (Vig.) and balance 5% equally distributed among ministerial staff members).
- (ii) 10% of admissible honorarium amount to concerned Dy.S.P. and Ministerial staff of his office (5% of admissible amount to Dy.S.P. and balance 5% equally distributed among ministerial staff members).

- (iii) 20% of admissible honorarium amount to SHO, APTPS (10% of admissible amount to SHO of concerned APTPS and balance 10% equally distributed among ministerial staff members).
- (iv) 60% of admissible honorarium amount in each case will be allowed to the concerned Constable of APTPS, who;
- Delivers and acknowledges the notices and writ of Demand to the PDC consumers.
 - Make detailed verification of the present address of defaulting consumers, and verify the address also
 - Make verification of the details of movable & immovable property of the PDC consumers
 - Make detailed verification of other prevailing electricity connections of the same PDC consumers.
 - Reporting the status of electricity being used or not.
 - Involve himself in assisting in the process of attachment of property by making publicity for attachment of property or playing drums in the premises of the PDC consumers, etc.

The honorarium allowed will be over and above to the existing incentive applicable to XEN, AEN, JEN, ARO and Ministerial Staff under EUDR/LR Act.

In all such cases, honorarium will be sanctioned by the concerned Circle SE after proper verification. A separate register/list of such PDC consumers will be maintained by the Unit Officers to avoid any double payment of honorarium and also further verification of realized amount by the Internal Audit Party.
