ORDER

As per Notification No. GOR, No. F.12(118)FD/Tax/2009-26 dated 5-06-2013, issued by the Finance Department (Tax Division), GOR in supersession to its earlier notification No. F.12(118)FD/Tax/2009-49, 100% Electricity Duty have been exempted for a period of seven years, to those eligible enterprises which have been established or shall be established as per sanction granted by the State Level Empowered Committee or District Level Sanctioning Committee, constituted under the Policy for Promotion Of Agro-Processing and Agri-Business-2010. For grant of exemption as above, the consumer has to produce "Entitlement Certificate" of the Administrator & Member Secretary of the respective Empowered Committees to the unit officers JVVNL.

To implement the above in billing, a new letter code "c" (small) is hereby allotted for suffixing the same at 5th place of the six digit tariff code. After receipt of necessary "entitlement certificate" as above, the unit officers shall send the revised tariff code of the consumer concerned to the billing agency, through input advice 2A. For new consumers, such advice may however be sent through MF1 itself.

The unit officers & AROs must ensure that, after completion of the exemption period, the tariff code of the consumer concerned is revised again and no exemption is allowed beyond the admissible period. For proper monitoring of such cases, register prescribed vide order No. 1056 dated 20.05.2011 (JPD-6/339) should be maintained in all units, without fail.
