## ORDER

In accordance with the REO Order No. JPD/DCE(R.E.)/SE(R.E.)/ F.1201/D.609 dated 27/08/2010 (REO-218) provision is to be made to allow subsidy of Rs.500/- per HP to those agriculture consumers who install three star or above rated pump sets approved by the Bureau of Energy Efficiency. This subsidy has to be adjusted equitably from energy bills to such consumers. Further instructions for adjustment of subsidy are issued for strict compliance with immediate effect.

1. The unit officer will provide the input advice CB-16 to the computer agency for adjustment in the bill mentioning therein amount and number of installments after following instruction as conveyed by the Chief Engineer(O & M),JVVNL.,Jaipur vide his letter no. 5105 dated 6/9/2010.
2. The amount shall be refunded in 12monthly installments in their energy bills. In case of bi monthly billing the number of installments would be six only.
3. The adjustment in bill may be allowed under transaction code 63.
4. The computer. Agency will prepare a journal voucher of the amount so adjusted by debiting the Account Head "Rebate/Subsidy to Agriculture consumers for Star Rated Pumps" under code head "78.832" and crediting to the Sundry Debtors for sale of Power"for BD as per order No . NO.JPD/CAO(Acctts)/F 58 / D. 1920 dt.3/9/10.
5. The necessary account wise output report mentioning the opening balance, amount adjusted during the month and balance to be refunded, to be provided to the unit officer every month by the computer agencies.


