

Terms & Conditions:-

1. The above official(s) are promoted on officiating basis.
2. They will be on probation for a period of one year from the date of their joining the duties on the post of Stock Verifier and their continuity on the posts will depend upon their satisfactory work and conduct during the probation period. The period of probations will be limited to the date of his superannuation/ retirement.
3. Their earlier promotion will not confer any right on the seniority over such other officials who could not be promoted for the present duty one of the other reasons and the seniority/ inter-se-seniority will be fixed later on.
4. During or at the end of the period of probation if they are found not to have made sufficient use of the opportunities or fail to perform satisfactorily. They will be reverted to their original post i.e. Asstt. Stock Verifier/ Asstt. Store Superintendent without notice.
5. They will have to join their duties as Stock Verifiers at the place of new posting within a period of 15 days from the date of issuing of posting order. Those who do not join within the specified period their promotion will stand cancelled after lapse of 15 days. Those who wish to forgo their promotion should intimate to this office immediately without waiting for 15 days period. The posting order will be issued separately.

6. Those official(s) who are under suspension or against whom enquiry is pending, which is likely to result imposition of a major/ minor penalty will not be relieved by the respective controlling officer for joining the post of Stock Verifier and the promotion so made under this order shall not be implemented . Information in this regard will be sent directly to this office immediately.



Fixation of pay will be made only to those, who have not been allowed the selection scale of the post of Stock Verifier as per provisions of relevant regulation of Nigam's ESR-1964.
