- 1. The above officials are promoted on regular basis and shall be on probation for a period of one year from the date of joining as Accountant/ARO or till attaining the age of superannuation whichever is earlier.
- 2. The seniority/ inter-se-seniority will be fixed later on.
- 3. Those officials who are under suspension or against whom enquiry is pending, which is likely to result imposition of a major/ minor penalty will not be relieved by the respective controlling officer for joining the post of Accountant/ ARO and the promotion so made under this order shall not be implemented. Information in this regard will be sent directly to this office immediately.
- 4. The above officials will have to join their duties as Accountant/ ARO at the place of new posting within a period of ten days from the date of issue of this order. The promotion order shall be deemed to stand cancelled in respect of those who do not join within the above specified period.
- 5. If anyone is not interested to avail the promotion, request in writing above forgoing the promotion shall be obtained by the controlling officer from him/her by aforesaid period and forwarded to this office and an entry in this regard be made in his/her service book. On forgoing promotion, he or she shall not be considered for promotion for next two DPC years.
- 6. A certificate in prescribed Performa as narrated in Nigam's order No. JPD/CAO/ATR/AO (Rules)/F.29/ D. 1259 dated 30-05-12 be also obtained by the controlling officer from above before relieving. If number of children of the above Jr. Accountants existing as on 01-04-12 increases thereafter and consequent upon such increase he/she has more than two children on or after 01-04-12 (excluding disabled child) his/her promotion order shall be deemed to have been cancelled.

7. The officials promoted under Fast Track Promotion scheme (Sr. No. 18 & 19) are required to get their requisite qualification documents verified with the original ones in the office of Asstt. Accounts Officer(Estt.-Cont), JPD, Jaipur before relieving to join their duty on promotion.

No further fixation benefit as admissible under rules on promotion to the post of Accountant/ ARO will be admissible to the officials, who are already in receipt of selection scale. Fixation of pay will be made only to those, who have not been allowed the selection scale as per provisions of relevant regulation of Nigam's ESR-1964.

The controlling officers are advised to send a copy of relieving /joining report to this office for further needful.
