ORDER

Pursuant to decision dated 02.12.2014 and 04.05.2015 of Hon'ble Rajasthan High Court, Jaipur in SBC WP No. 16644/2013 & No. 16817/2013, the Selection Committee considered promotion from the post of LDC/CCC to UDC for the year 2007-08. On recommendation of Selection Committee, as approved by the Hon'ble Chairman & Managing Director, JVVNL, the following LDCs/CCCs are hereby appointed on promotion to the post of UDC against the vacancies for the year **2007-08** in terms of Regulation No. 6.1(ii) of MSR-1962. Except those who stood retired/expired or ceased to be on the post of LDC/CCC due to one or other reason, on promotion they will remain posted in the same office, where working presently as indicated in column No. 8, as under:-


NOTE:-

1. All the aforesaid existing employees will have to submit their joining report within 15 days of issuance of order to the controlling officer as indicated in above column 8. In case the place of posting as mentioned against his/her name has been changed, he/she will submit joining report, in the office where-in presently working. A photo copy of joining report of concerned employee be sent to this office by the controlling officer.

2. The concerned controlling officer will ensure that if an employee has been transferred to any other office, intimation to this regard be given to this office immediately.
3. Such candidates who are getting selection grade in pay scale of UDC or higher will not be allowed further fixation of pay in the Pay Scale of UDC, however, if anyone is getting SG/ACP in lower grade than UDC, he/she will be allowed only the difference of Grade Pay of the post of UDC.
4. If anyone is not interested to avail the promotion, request in writing about foregoing the promotion, shall be obtained by the controlling officer from him/her and forward to this office. An entry in this regard be made in his/her service book. The benefit of 2nd and 3rd selection grade shall also be withdrawn from the date of foregoing the chance of promotion, as per order No. RSEB/F&R/F.16(13)/I/D.40 dated 25.07.1997, in respect of those appointed as LDC by way of promotion from the post of Class-IV.


