1. Tender shall be submitted online only through <http://eproc.rajasthan.gov.in>. The tender documents can be downloaded from this website.
2. Tenderer should be registered with service tax department. The copy of service tax registration shall have to be uploaded in tendering.
3. No physical / offline Tender / bid shall be accepted.
4. The contractor must have sufficient experience of execution of similar type of works in Govt. department / Public Enterprises.
5. The tender cost & Earnest money shall be in the form of demand draft or banker cheque of schedule Bank Drawn for the work mentioned at Sr. No. 1 to 7 in favour of Accounts Officer (O&M), JVVNL, Kota, Sr. No. 8 to 16 in favour of Accounts Officer (JCC), JVVNL, Jaipur, Sr. No. 17 & 18 in favour of Accounts Officer (O&M), JVVNL, Bharatpur and shall be submitted offline / manually in the office of the respective Executive Engineer (Civil), JVVNL, Kota/Jaipur/Bharatpur/ QC, Jaipur upto scheduled date & time. Earnest money will be deposited @2% of estimated cost of work for other department registered contractor and for JVVNL contractors earnest money shall be deposited as per rule. The scan copy of DD/BC for earnest money, tender cost & processing fee shall also be uploaded.
6. The processing fee shall be in form of demand draft / Banker Cheque of schedule Bank drawn in favour of Managing Director (RISL) payable at Jaipur and shall be offline / manually submitted in the office of the respective Executive Engineer (Civil) JVVNL, Jaipur/Bharatpur/ QC, Jaipur to schedule date & time.
7. On award of contract, the work should have to be started within 15 days from issue of work order, otherwise work will be withdrawn as per contract agreement.
8. The under signed reserves right to cancel the BID without assigning any reason to the bidder or anyone else.
9. The electricity for work execution shall be arranged by the bidder at his own source.
10. The water shall be provided if available free of cost at one point nearer to the water source, otherwise arranged by agency at his cost.
11. The service tax, Royalty & other taxes payable, if any, under the contract shall be paid by the bidder.
12. The rate quoted will valid for 120 days from the date of opening of tender / BID.
13. The Bidder shall have to submit a certificate that he has an establishment covered under the provision of EPF Act. 1952 and having a separate registration with PF commissioner in absence of the same, the contractor shall be liable to deposit employee's as well as employer's contribution (in respect of employee's engaged by him for the said work) with JVVNL along with details of such employees and deduction as per JVVNL CPF Rules shall be made from his bills / security deposit.
14. Conditional tenders and casual letter sent by the contractor will not be accepted.

15. Any representation after opening of tender shall be ignored. These parties may be debarred from tendering in future for A specific period. Their earnest money in such cases will stand forfeited.
16. The bidders should inspect the site of work prior to filling the tender.
17. The test moulds for respective work shall be transported by contractor to Quality control lab, Jaipur for testing at his own cost.
18. The Qualified Engineer / Supervisor are to be deputed by contractor at work site.
19. Temporary approach for construction, hutments for working labour etc. are to be constructed by the contractor at his own cost & no payment shall be admissible for this.
20. Looking to the urgency of work, the contractor may asked to complete the any part of work on priority and contractor will complete the said part as per requirement of department without any compensation.
21. Bidders are requested to read the instruction in the tender documents / bid before submitting the tender / bid online.
