Clarification under Tender TN-67

In the tender "Deployment of Smart Office (E-office)" under TN-67, the following amendments are made in the RFP:

The clarifications for the queries are as below:

S. No.	Clarification Sought	Decision
1.	Please provide the total number of sub office and offices where the smart office shall be installed.	In addition to list of offices available in RFP clause No. 21 (C), 1.1 Stage –I, II, III, IV & V & the Sub offices shall be approximately 101 Nos. of JPDC circle. (Annexure-1)
2.	As per the amendment a scanner with 500-page scanning capacity has to be installed at offices. Kindly specify the number of offices where these scanners have to be installed and minimum specification of the scanner. Do we require to deploy A3 or A4 size scanning capability scanner?	A4 and legal both are the most commonly used paper sizes, scanner should be compatible with the computers being used.



3.	As per the RFP the only hardware that need to be deployed at all sub offices is the scanner and JVVNL has other hardware like Desktops etc., if not kindly specify the configuration, quantity and minimum specification of other hardware that need to be deployed.	The specification/configuration of hardware should be compatible with the scanners.
4.	Request to provide the number of scanning stations to be established.	As clarified in point (1) above.
5.	Please find enclosed the MSME certificate issued by Govt. of Rajasthan. We request you to kindly confirm if we can pay the reduced EMD as per the latest amendment.	The MSME certificate is to be obtained from the GOR. However the reduced EMD shall be 0.5% of Rs. 20 Lakhs.
6.	Copy of Self-Attested Partnership Deed	It is clarified that in case of partnership firm, the copy of self attested partnership deed is required. It is necessary as per amendment D. 584 dt. 02.07.18, point No. C). Qualification Requirement for bidder.
