

Subject:- Permission for exercise of option / re-option under the Rajasthan Civil Services (Revised Pay) Rules, 2017

The Rajasthan Civil Services (Revised Pay) Rules, 2017 have been promulgated with effect from 01.10.2017 vide Finance Department Notification No. F.15(1)FD(Rules)/2017 dated 30.10.2017. These rules have further been modified and made effective w.e.f. 01.01.2016 instead of 01.10.2017 vide FD Notification of even number dated 09.12.2017. The Rules 8 and 9 of these rules provide for exercise of option within three months from 09.12.2017.

It has been brought to the notice of the Government that some of the Government servants could not exercise option within the time limit prescribed under Rule 9(1) and in terms of provisions contained in sub-rule 3(i) and (4) of Rule 9, they were deemed to have exercised option for revised pay scales 2017 w.e.f. 01.01.2016, which might have resulted in a recurring disadvantageous position. Likewise some of the Government servants have exercised option incorrectly without understanding the proper implications of the rules governing fixation of pay. The exercise of such incorrect option has put them to recurring financial loss.

The matter has been considered sympathetically and it has been decided that all Government servants may be permitted to exercise option / re-option under Rule 8 and 9 of the aforesaid rules within three months from the date of issue of this Memorandum.
