Sub: Grant of Dearness Allowance to the employees of Jodhpur Discom.

In exercise of powers conferred vide order No. JdVVNL/MD/ Secy.(Admn.)/Ju/S.Estt./F. / OO.372 / D.1521 dated 18.01.2012, the Managing Director, Jodhpur Discom, Jodhpur, is pleased to adopt the State Government's order No. F.6 (3) / FD (Rules) 2017 dated 10.09.2018. Accordingly, the existing rate of Dearness Allowance payable to the employees of Jodhpur Discom, vide this office order No. F.1 () /JdVVNL/Ju./ CAO (B&R) / AO (Estt.&Cont.) / OO.14/D.73 dated 13.04.2018 shall be revised from 7% to 9% w.e.f. 01.07.2018.

The term 'Pay' for the purpose of calculation of Dearness Allowance shall be the basic pay i.e. pay drawn in the Pay Matrix of the prescribed Levels and shall not include any other type (s) of pay like Special Pay or Personal Pay etc.

The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.

The amount of increase in Dearness Allowance i.e. 2% shall be added in the salary for the month of September, 2018 and onwards alongwith respective month's salary. Arrear of increased Dearness Allowance i.e. 7% to 9% for the period from 01.07.2018 to 31.08.2018 will be arranged/released in one instalment with the salary for the month of September, 2018.

The increased D.A. shall also be admissible and paid in cash to the employees who were in service on or after 01.07.2018 but ceased to be in service prior to the issue of this order, whether for disciplinary reasons or on account of resignation, retirement, death or discharge or abolition of sanctioned post.
