ORDER

Sub: Grant of Dearness Relief to the Pensioners of JdVVNL.

In exercise of powers conferred vide order No.JdVVNL/MD/ Secy.(Admn.)/Ju/S.Estt./F. / OO.372 / D.1521 dated 18.01.2012, the Managing Director, Jodhpur Discom, Jodhpur, is pleased to adopt the State Government's order No. F.12 (8) / FD (Rules) 2017 dated 10.09.2018 issued by the Finance Department (Rules Division), Govt. of Rajasthan regarding grant of Dearness Relief to the State Government's Pensioners for application in respect of pensioners of Jodhpur Discom from 7% to 9% w.e.f. 01.07.2018. Accordingly, the existing rate of Dearness Allowance payable to the pensioners of Jodhpur Discom, vide this office order No. F.1 () /JdVVNL/Ju./ CAO (B&R) / AO (Estt.&Cont.)/ /OO.19/D.80 dated 19.04.2018 shall be revised from 7% to 9% w.e.f. 01.07.2018.

Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to next higher rupee. The provisions of this order shall also be applicable to the pensioners of erstwhile RSEB.

The amount of Dearness Relief at increased rate for the month of September, 2018 and onwards shall be paid alongwith Pension for respective month and the arrears of increased Dearness Relief i.e. 7% to 9% for the period from 01.07.2018 to 31.08.2018 will be arranged/ released in one installment with the pension for the month of September, 2018.


