ORDER 428

Presently most of the activities under O&M Circles are being done in Jodhpur Discom on prescribed Central Labour Rate Contract (CLRC) except in Central sponsored Schemes/ Turnkey works. In CLRC works material is being arranged by Jodhpur Discom.

In order to streamline the works, it is hereby directed that henceforth, no work under CLRC amounting to Rs. 5.00 lac or more, shall be carried out in respect of following works:-

1. New 33/11 KV S/S
2. New 33/11 KV lines
3. 33 & 11 KV Under Ground Cabling work


In all above cases where value of G-Schedule as per CLRC in force is Rs. 5 lac or more, concerned Superintending Engineer shall send the case through Zonal Chief Engineer to Superintending Engineer (TW), Jodhpur Discom, Jodhpur who after following the procedure prescribed under RTPP Act, 2012 & RTPP Rules, 2013 will call open competitive bidding to get the contract (s) awarded.

The circle SE shall ensure sending of G-Schedule item wise with quantity, copy of Administrative & Technical Sanction of estimate of competent authority work wise and details of amount deposited in case of deposit works alongwith budget provision i.e. 33/11 KV GSS, 33KV, 11KV lines, 33 KV, 11KV Under Ground Cabling work for each activity wise once in a month latest by 7th of each month. SE (TW) after receipt of such work wise Schedule received upto 7th of each month, shall consolidate the work activity wise and start activity wise tendering process or by making suitable lots.

It has also been decided that in all above cases where approval for carrying out such work (s) having value of Rs. 5.00 lac or more has already been accorded by the competent authority but orders are in pipeline for issue, the same shall not be issued.

This bears the approval of Managing Director, Jodhpur Discom, Jodhpur.


