ORDER 136

Sub: Adoption of Finance Department, GoR's Notification/orders dated 06.04.2013 regarding amendments in Rajasthan Civil Services (Revised Pay) Rules, 2008.

Pursuant to the decision taken by the Co-ordination Committee in its 166th meeting held on 17th June, 2013, following Notifications/orders issued by the Finance Department, GoR, are hereby adopted mutatis-mutandis:-

Accordingly, the following amendments are hereby made in the Nigam's order No. 181 D. 1305 Dt. 01.10.2008 of Revised Pay Scales Rules, 2008 on the lines of amendments as made by the GoR vide above mentioned Notifications/Orders Dated 06.04.2013:-

(A) (i) In the Nigam's Order No. F.(1)JdVVNL/JU/Director (F)/S.Control/F.6thPC/D/OO. 181/D.1305 Jodhpur Dt. 01.10.2008 along with its Annexure-A, the following shall be substituted:-

(ii) The existing "Note" appearing below sub-rule (4) of Rule 5 of Annexure-A appended with order No. 181 dt. 01.10.2008 be re-numbered as "Note-1" and the following new "Note-2" shall be inserted, namely:

"In case where as Government Servant opts revised pay scale with effect from 01.01.2006 and whose annual grand increment falls between 2nd January, 2006 to 30th

June, 2006 (both days inclusive) shall be granted one increment in the existing pay Scale on 01.01.2006.”

- (iii) After the existing sub-rule (5) of Rule 11 of Annexure-A appended with order No. 181 dt. 01.10.2008, the following new sub-rule (6) shall be inserted, namely:-

“A Govt. Servant who has opted revised pay scale from a specific date as per provisions of Rule 11 of these rules in force prior to this Notification, if not willing to revise the existing option, he may continue to retain his existing option.”

- (iv) The existing form of option under Rule 10 & 11 of Annexure-A appended with order No. 181 dt. 01.10.2008 shall be substituted by the form of option appended with Finance Department (Rules Division), GoR's Notification No. F.14 (1) FD (Rules)/2013-II dated 06.04.2013.

- (v) The existing sentence second of Rule-14 of Annexure-A appended with order No. 181 dated. 01.10.2008 shall be substituted by the following namely:

“The first increment after fixation of pay on 01.01.2006 in the running pay band will be granted to the employees, who have completed six months in RPB on 01.07.2006.”

- (vi) The existing para No. 4 of order No. 181 dt. 01.10.2008, shall be substituted by the following namely:

“Notwithstanding anything contained in this order and in Rajasthan Civil Services (Revised Pay) Rules, 2008, no arrear of pay and allowances thereon, whatsoever on any account shall accrue to any employee, whether existing or appointed between 01.01.2006 to 30.06.2013 (both days inclusive) i.e. for the period upto 30.06.2013.”

- (vii) After the existing Rule 26 of Annexure-A appended with order No. 181 dt. 01.10.2008, the following shall be inserted as new Rule 27 namely:-

“27. Notwithstanding anything contained in these Rules, no arrear of pay and allowances thereon, on any account shall accrue to a Government Servant whether existing or appointed between 01.01.2006 to 30.06.2013 (both days inclusive) for the period up to 30.06.2013.”

- (viii) In the Nigam's order No. 181 dt. 01.10.2008, the following amendments shall be made w.e.f. 01.07.2013:-

- (a) In Annexure-B, the existing entries of existing Pay Scale No. 9,10, 11 &12 shall be substituted by the following, namely:-

- (b) In Table No. 7 (C-7), Table No.8 (C-8), Table No. 9 (C-9) and Table No. 10 (C-10), the existing Grade Pays Rs. 3,200, Rs. 3,500, Rs. 3,600 and Rs. 4,200 respectively, appearing at the top of table and in column No. 3 of respective table, shall be substituted by the Grade Pays Rs. 3,600, Rs. 3,950, Rs. 4,200 and Rs. 4,600 respectively.

Explanation: The pay in the further revised Running Pay Band and Grade Pay shall be fixed as per provisions contained in Rule 27 of Annexure-A appended with order No. 181 dt. 1.10.2008.

- (c) In Column No. 7 of Annexure-G (Amount of fixed remuneration for Probationer Trainee), the existing grade pays of Rs. 3,200, Rs. 3,600 and Rs. 4,200 shall be substituted by the Grade Pays Rs. 3,600, Rs. 4,200 and Rs. 4,600 and in last column of table the respective existing amount of fixed remuneration of Rs. 10,000, Rs. 11,100 and Rs. 13,050 shall be substituted by the amount of Rs. 11,100, Rs. 13,050 and 14,000 respectively.
- (ix) In Annexure-H (Entry pay in the Running Pay Bands and Grade Pays for Direct Recruits appointed on or after 1.09.2006 on satisfactory completion of probation period) appended with Nigam's order No. 190 dt. 23.10.2009 below heading PB-2 (9300-34800), the existing Grade Pay No. 11,12,13 and 14 shall be substituted by the following w.e.f. 01.07.2013:-

- (x) After the existing Rule 27 as per point (vii) above, in Annexure-A appended with Order No. 181 dt. 1.10.2008, the following shall be inserted as new Rule 28, namely:-

"28 Method of Fixation of Pay in the Running Pay Band and Grade Pay further revised after 01.01.2006:-

The initial pay of a Government servant who elects or is deemed to have elected Running Pay Band and Grade Pay further revised after 01.01.2006 shall be fixed at on equal stage in the Running Pay Band plus Revised Grade Pay of the post. In case the pay last drawn in the existing Running Pay Band is less than the minimum of the further revised Running Pay Band, he shall be fixed at the minimum of the Running Pay Band plus Grade Pay of the post.

- (B) The Assured Career Progression shall be in the immediate next higher Grade Pay in hierarchy of the Running Pay Band and Grade Pay as given in the Annexure-B, appended with Nigam's Order No. 181 dated 01.10.2008, and in 'Table A' of Nigam's order No. 46 & 47 dated 27.05.2010. Consequent upon revision of Grade Pay approved in the Annexure-B (at para viii (a) above), appended with Nigam's order No. 181 dt. 1.10.2008. The Grade Pays already granted under the Assured Career Progression Scheme vide Nigam's order No. 46 & 47 dated 27.05.2010 shall be revised, w.e.f. 01.07.2013, as under:-
