ORDER 160

Sub: Adoption of Finance Department, GoR's Notification/memorandum dated 06.04.2013 regarding amendments in Rajasthan Civil Services (Pension) Rules, 1996.

Pursuant to the decision taken by the Co-ordination Committee in its 166th meeting held on 17th June, 2013, the following Notifications/Memorandum dated 06.04.2013 issued by the Finance Department, GoR regarding amendments in Rajasthan Civil Services (Pension) Rules, 1996 be adopted, mutatis-mutandis:

Accordingly, the following amendments are hereby made in the Nigam's order No. 182 D.1306 Dt. 01.10.2008 of Revised Pension Rules, 2008 on the lines of amendments made by the GoR vide above mentioned Notifications/Memorandum Dated 06.04.2013:-

- (i) The amendments made in Rule 42, 43, 45, 54 (2) (b), 54 A, 127, 152, 153, 155, 157 and in Rule 4 of Appendix V vide Notification dated 12.09.2008 (Annexure-B), appended with Nigam's order No. 182 D. 1306 dt. 1.10.2008, shall be deemed to come in to force from 1.01.2006 instead of 1.09.2006.
- (ii) In clause (a) of sub-rule (2) of Rule 54 and clause (i) of Rule 62 (Annexure-B) appended with Nigam's order No. 182 D. 1306 dated 1.10.2008 the figures 01.09.2006 shall be substituted by the figures 01.01.2006.

- (iii) **Non-Accrual of Arrears:** The State Government has further revised the Pay Scales of Govt. Servants w.e.f. 01.01.2006 with the condition that no arrears would accrue for the period from 01.01.2006 to 30.06.2013. Accordingly on the same lines in respect of Government servants retired/died while in service during the period 01.01.2006 to 30.06.2013, no arrear of Pension/Family pension shall accrue upto 30.06.2013. Pension/Family Pension calculated on existing pay (retired between 01.01.2006 to 31.12.2006) and Pre Revised Pay (retired between 01.01.2007 to 30.06.2013) as the case may be shall only be payable upto 30.06.2013 and the Pension/Family pension on revised notional pay as per the above mentioned amendments shall be payable with effect from 01.07.2013. The Commutation and Gratuity to these Government servants shall not be admissible on the revised notional pay and the amount of Commutation/Gratuity already paid/payable on the existing pay or pre-revised pay shall be treated as final.
- (iv) The existing Rule 51 and 52 of RCS (Pension) Rules, 1996, shall be deleted.
- (v) The existing clause (a) & (b) of sub-rule (2) of Rule 54 of RCS (Pension) Rules, shall be substituted as follows:
- (i) In the case of a Govt. servant retiring in accordance with the provisions of these rules after completing qualifying service of not less than twenty eight years, the amount of pension shall be calculated at fifty percent of the emoluments subject to maximum upto fifty percent of the highest pay in Govt. (the highest pay in Govt. is Rs. 77,000/- since 01.01.2006 whereas the same is Rs. 67,000/- in place of 77,000/- in case of Nigam as defined in Nigam's order No. 182 dt. 01.10.2008, under Rule 45 of these rules, which the Government servant was receiving immediately before the date of retirement. This provision shall come into force w.e.f. 01.07.2013.
- (vi) In case of Govt. servant retiring in accordance with the provisions of these rules before completing qualifying service of twenty eight years but after completing qualifying service of ten years, the amount of pension shall be proportionate to the amount of pension admissible under Clause (a) and in no case the amount of pension shall be less than rupees three thousand twenty five per mensem. This provision shall come into force w.e.f. 01.07.2013.


(vii) The existing word and figures 01.09.2006, 31.08.2006 and 'pre 01.09.2006' wherever occurring in order No.182 dated 1.10.2008 shall be substituted by the word and figures '01.01.2006', '31.12.2005' and 'pre-01.01.2006' respectively.

(viii) The existing para 14 (Non accrual of arrears for the period from 01.09.2006 to 31.12.2006) (Annexure-A, appended with Nigam's order No. 182 dated 01.10.2008) shall be substituted by the following:-

Notwithstanding anything contained in this order no arrears shall be payable for the period from 01.01.2006 to 31.12.2006 on account of consolidation of pension/family pension.


