Sub: Grant of Dearness Allowance to the employees of Jodhpur Discom.

In exercise of the powers conferred vide order No. JdVVNL/C&MD/CS/F./OO.172/D.684 dated 5.11.2001, the Director (Technical), Jodhpur Discom, Jodhpur in consultation with Director (Finance), Jodhpur Discom, Jodhpur has been pleased to adopt the State Government's order No.F.6 (1)/FD (Rules)/ 2008 dated 13.04.2015. Accordingly, the existing rate of Dearness Allowance payable to the employees of Jodhpur Discom vide this office order No. F.1 () /JdVVNL/Ju./ CAO (B&R) /AO (E&C)/ /OO. 204/D.625 dated 22.09.2014 shall be revised from 107% to 113% w.e.f. 01.01.2015.

The term 'Pay' for the purpose of calculation of Dearness Allowance shall be the Basic Pay i.e. sum of pay in running pay band with grade pay drawn and shall not include any other type (s) of pay like special pay or personal pay etc.

The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.

The amount of increase in Dearness Allowance i.e. 6% shall be added in the salary for the month of April, 2015 and onwards alongwith respective month's salary. Arrear of increased Dearness Allowance i.e. 107% to 113% for the period from 01.01.2015 to 31.03.2015 will be arranged/released in two equal instalments with the salary for the month of April, 2015 (Payable in May, 2015) and May, 2015 (Payable in June, 2015) respectively.

The increased D.A. shall also be admissible and paid in cash to those employees who were in service on or after 01.01.2015 but ceased to be in service prior to the issue of this order, whether for disciplinary reasons or on account of resignation, retirement, death or discharge or abolition of sanctioned post.
