Sub:- Grant of Assured Career Progression under Rajasthan Civil Services (Revised Pay) Rules, 2008.

In exercise of the Powers conferred vide order No. JdVVNL/C&MD/CS/F-/00. 172/D. 684 dated 05.11.2001, the Managing Director, Jodhpur Discom, Jodhpur is pleased to adopt the Finance Department, GoR's Memorandums No. F.14(88)/FD /Rules/2008-I dated 06.10.2015 and No. F.14 (88) FD/Rules/2008-II dated 06.10.2015.

Accordingly, existing item (iii) of Sub para 7 of para 2 of Nigam's order No. F(1) IdVVNL/ JU/Director(F)S.Control/F.ACP/00.46/D.346 dated 27.05.2010 & the existing item (iii) of Sub para 8 of para 2 of Nigam's order No. F(1) JdVVNL/ JU / Director (F) S. Control / F.ACP /00.47/ D.347 dated 27.05.2010 shall be substituted by the following namely:-

"The appointing authority shall also obtain an affidavit from the employee with reference to having only two children on or after 01-06-2002 prior to granting ACP. An employee who has more than two children on or after 01.06.2002 shall not be grarted next ACP for five years from the date on which his ACP is become due and it would have consequential effect on the subsequent financial up-gradation which would also get deferred to the extent of delay in grant of previous financial up-gradation. The employee having more than two children shall not be deemed to have been disqualified, so long as the number of children he/she has on 01.06.2002 does not increase."

This is subject to ratification by the Board of Directors.
