## ORDER 350

In reference to the letter dated 20.10.2017 of Under Secretary to the Govt. of India (MoP) regarding operational guidelines for Pradhan Mantri Sahaj Bijli Har Ghar Yojna (Saubhagya Scheme) for implementation of the scheme, as per Chapter II Project Formulation and Implementation Clause No. 2.3; an amount of Rs. 500/- per household for release of connection would be recovered by the Discom in ten (10) equated monthly/bi-monthly installments of Rs. 50/- each through electricity bills. In this context for all household categories the new letter code "SB" (capital) in 5<sup>th</sup> & 6<sup>th</sup> place of tariff code "1xxx" and the new sundry code "89- Consumer contribution towards Saubhagya Yojna (EMI)" under CB-4 is hereby prescribed.

The above order shall come into force with immediate effect.
