ORDER 148

In pursuance of the letter F.7(22) Energy/2016 dated 16.07.2018 issued by Energy Department, GoR, BPL consumers of TSP and Sahariya areas are not required to pay any charges to Discoms upto 50 units consumption per month in Domestic Category(DL-BPL). Applicable tariff & tariff subsidy in respect of BPL consumers of TSP and Sahariya areas shall be as under:-




