**ORDER 149**

It has been stipulated vide No. F.1 ( )/JdVVNL/Ju./CAO (B&R)/Sr. AO (Rev.)/OO. 428 /D. 2311 Dt. 21.03.2018 that no work under Central Labour Rate Contract (CLRC) amounting to Rs. 5.00 Lakh or more shall be carried out in respect of following works on CLRC:-

1. New 33/11 KV S/S.
2. New 33/11 KV lines.
3. 33 & 11 KV Under Ground Cabling work.

Difficulties are being faced and are also regularly being intimated by the field officers regarding delay in release of agriculture connections, house hold electrification and other service connection related works due to delay in award of contract through bidding process.

In order to ensure timely release of agriculture connections, house hold connections and other connections within the prescribed limit of power for all and standard of performance laid down by RERC, it has been decided that work for release of agriculture connection, house hold electrification and other service connections involving 33/11 KV overhead/ Under Ground Cable, 11KV S/S along with associated LT works be carried out on existing CLRC in-force till new rate contract is finalised, even if the value of G-Schedule as per existing CLRC is amounts to Rs. 5.00 Lakh or more. The work order for the above service connection activities shall be awarded by the officers as per existing DOP in-force vested on them, out of roster also, if needed.

The order No. F.1 ( )/JdVVNL/Ju./CAO (B&R)/Sr. AO (Rev.)/OO. 428 /D. 2311 Dt. 21.03.2018 is hereby stands partially amended as above.


