Ref:- Comml. JDP/918 dated 28.08.2019.

Fuel Surcharge @ Rs. 0.05 per unit (Kwh) has been prescribed by JdVVNL in exercise of power conferred under clause 88 of RERC (Terms & Conditions for determination of tariff) Regulation, 2014 for the 1st quarter i.e. April'2018 to June'2018 of the Financial Year 2018-19, recoverable on the consumption of previous quarter i.e. January, 2018 to March, 2018 for 36 months, w e f Billing month September'2019 onwards **through separate sundry code.**

Further, the fuel surcharge to the "Agriculture (M&F), Small Domestic and BPL" category consumers being part of the subsidy by Govt., is to be billed but not be payable by the consumers.

You are, therefore, directed to incorporate this in the forthcoming bills for 36 months, w e f Billing month September'2019 onwards. and ensure that proper timely arrangement are made for levy of the special fuel surcharge as above in the bills at the earliest possible. Further, provide the category wise vis-à-vis circle wise fuel surcharge amount recoverable from the consumers and the amount of fuel surcharge for subsidized agriculture consumers with the energy consumed for the consumption month January, 2018 to March, 2018 to this office within a week positively.

Sub. : BRD approval for special fuel surcharge for 36 months @ Rs. 0.05/unit.

On the above cited subject, BRD is hereby approved with some of the following observations to be considered within:-

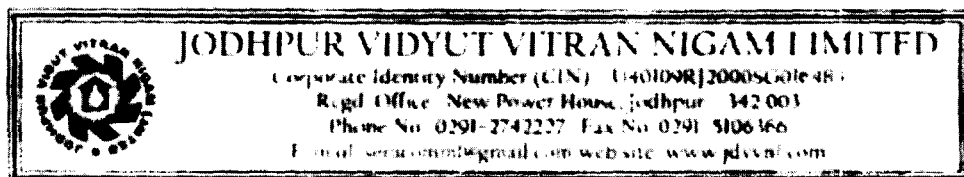
1. 18 installments (Bi-monthly billing) to be charged @ Rs. 0.10 per unit and 36 installments (Monthly billing) to be charged @ Rs. 0.05 per unit against the consumption during April 18 to June 18 (in line with Coml. 918 Dated 28.08.2019)
2. Fuel surcharge amount should be shown in bill column no. 8 and fuel surcharge subsidy shall be covered under tariff subsidy and will be shown in bill column no. 23 (ReqID_4 & 5 of clause 2.1 of BRD)
3. Fuel surcharge shall be charged for 91 days. (01.04.2018 to 30.06.2018)
4. Impose all the amount of special fuel surcharge in single installment, if consumer found active/regular in base period (i.e. 01.04.2018 to 30.06.201) but current status of the consumer is DC/PDC as on today.

ORDER

Sub: Recovery of Special Fuel Surcharge amount.

In compliance of the RERC order dated 13.06.2019 in the Petition No. 1464/2019 read with clause 88 of the RERC (Terms & Conditions for Determination of Tariff) Regulation, 2014, the recovery of additional power purchase cost, the Jodhpur Discom hereby prescribes application of Special Fuel Surcharge at the rate of **Rs. 0.05 per unit (KWh)** recoverable on the consumption of 1st quarter of the Financial Year 2018-19 (April, 2018 to June, 2018) for 36 months, w.e.f. B.M. September, 2019 onwards.

The above rate has been decided in terms of the order "Tariff for supply of Electricity-2017" and shall be over and above the rate of charge(s) prescribed in the said tariff order.

The CAO (B&R), Jodhpur Discom will work out the amount of fuel surcharge in respect of subsidized category of consumers for claiming subsidy from Government of Rajasthan in order to keep effective charging from such consumers remain unchanged.
