### ORDER 298

Sub:- Payment of Bonus/Ex-gratia to the employees of the Nigam for the financial year 2014-15.

Consequent upon approval of the Energy Department, GOR conveyed vide order No. F12(32)Energy/2008/pt. dated 06.11.2015, Bonus for the financial year 2014-15 shall be paid to the employees of the Nigam as per payment of Bonus Act who are in purview of the Act and the payment of ex-gratia would be admissible to the employee drawing pay in the grade pay of Rs.4800/- or less and it would not be admissible for Probationer Trainees. The payment of Bonus/ Ex-gratia, as above, shall be arranged with immediate effect. No overtime/ honorarium will be allowed to any employee for preparation/ passing of the claims related to payment of Bonus/ Ex-gratia.
