ORDER 318

Sub:- Procedure for sanction of additional pension/family pension admissible to old pensioners/family pensioners on attaining age of 80 years or above at par with Government pattern.

The Co-ordination Committee in its 187th meeting held on 30.12.2015 has decided that Additional Pension shall automatically be increased at par with the government pattern taking into consideration the date of birth of pensioner/family pensioner and alive certificate, by the Pension Payment Authority on his own.

Accordingly, sub-para (iv) (i.e. "Additional Pension") of Nigam's order No. F(1)}dVVNL/JU/Director(F)/S.Control/F.6th PC/D. 1306 Jodhpur Dated 01.10.2008 regarding Revised Pension Rules, 2008 shall be substituted by the following namely:-

(vi) The Additional Pension shall automatically be increased at par with the government pattern as prescribed in Rule 54A of Rajasthan Civil Service (Pension) Rules, 1996 taking into consideration the date of birth of pensioner/family pensioner and alive certificate, by the Pension Payment Authority on his own."

This bears the approval of the Managing Director, JdVVNL and is subject to ratification by the Board of Director of the Nigam.
