ORDER

Sub: Grant of Dearness Allowance to the employees of Jodhpur Discom.

In exercise of the powers conferred vide order No. JdVVNL/C&MD/CS/F./OO.172/D.684 dated 5.11.2001, the Managing Director has been pleased to adopt the State Government's order No.F.12 (4)/FD (Rules)/ 2008 dated 27.09.2012. Accordingly, the existing rate of Dearness Allowance payable to the employees vide this office order No. F.1()/JdVVNL/Ju./CAO (A&R)/AO (E&C)/F. DA/OO. 13/D.72 dated 11.04.2012 shall be revised from 65% to 72% w.e.f. 01.07.2012.

The term 'Pay' for the purpose of calculation of Dearness Allowance shall be the Basic Pay i.e. total of pay in running pay band and grade pay drawn and shall not include any other type (s) of pay like special pay or personal pay etc.

The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.

The amount of increase in Dearness Allowance i.e. 7% shall be added in the salary for the month of October, 2012 and onwards alongwith respective month's salary: Arrears of increased Dearness Allowance i.e. 65% to 72% for the period from 01.07.2012 to 30.09.2012 will be arranged/released in one instalment with the salary of October, 2012 payable in November, 2012.

The increased D.A. shall also be admissible and paid in cash to those employees who were in service on or after 01.07.2012 but ceased to be in service prior to the issue of this order, whether for disciplinary reasons or on account of resignation, retirement, death or discharge or abolition of sanctioned post.
