**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is pleased to make the following rules to amend further the Rajasthan Civil Services (Revised Pay) Rules, 2008, namely:-

**1. Short title and commencement.-** (1) These rules may be called the Rajasthan Civil Services (Revised Pay) (Second Amendment) Rules, 2015.

(2) They shall be deemed to have come into force with effect from 01.07.2015.

**2. Amendment of Schedule-IV.-** The existing table of Schedule-IV, except Note appearing below the said table, appended to the Rajasthan Civil Services (Revised Pay) Rules, 2008, shall be substituted by the following, namely:-
