Rajasthan Civil Services (Revised Pay) Rules, 2008.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is pleased to make the following rules to amend further the Rajasthan Civil Services (Revised Pay) Rules, 2008, namely:-

- 1. These rules may be called the Rajasthan Civil Services (Revised Pay) (Second Amendment) Rules, 2014.
- 2. They shall be deemed to have come into force with effect from 01.09.2014.
- In the Rajasthan Civil Services (Revised Pay) Rules, 2008 the existing Schedule IV (Rule 21) - Amount of Fixed Remuneration for Probationer Trainee excluding 'Notes' appearing thereunder shall be substituted by the following, namely:-
